At Sytchampton Endowed Primary School we ensure that we meet the individual, learning needs of all our pupils through our excellent teaching and learning, providing differentiated work and a personalised approach. We have high expectations for all pupils, including those with special educational needs and/or disabilities, ensuring the best possible progress for our pupils through an exciting curriculum.

This document is intended to give you information regarding the ways in which we support our pupils, including those with SEND, to enable them to reach their full potential. Some of our strategies, skills and resources are listed below, however, support is tailored to the individual child and provision is modified regularly.

Every child receives quality first teaching within the classroom but for those pupils who may require further support, additional help may be provided through group interventions with those pupils who have similar needs.

<p><b>Communication and interaction</b>  <i>Children with SLCN have difficulty in communicating with others. <p><b>Cognition and learning</b>  <i>Support for learning difficulties may be required when children learn at a slower pace than their peers, even with appropriate differentiation. Learning difficulties cover a wide range of needs:  Children with Moderate (MLD) and Severe Learning Difficulties (SLD) are likely to need support in all areas of the curriculum and associated difficulties with mobility and communication.  Children with Profound and Multiple Learning Difficulties (PMLD) are likely to have severe and complex learning difficulties as well as physical disability or sensory impairment. We have a pupil clinic in staff meetings, which is recorded in the staff meeting minutes.</li> <li>• The SENCo completes observations for individual pupils to identify needs.</li> <li>• Pupils, parents and staff are all involved in the planning, implementation and reviewing of individual provision maps.</li> <li>• Individual provision maps are reviewed termly with parents, the pupil and staff focusing on the pupil's individual targets during parent meetings.</li> <li>• External specialist advice contributes to assessments and reviews, supporting targeted programmes and interventions.</li> <li>• Referrals are made to Early Help through a multi-agency approach.</li> <li>• Home-school liaison is on-going.</li> </ul> <p style="text-align: center;"><u>Staff Roles and Responsibilities</u></p> <ul style="list-style-type: none"> <li>• All staff meet the 2012 Teachers Standards adapting their teaching to respond to the strengths and needs of all their pupils including those with SEND and within vulnerable groups of learners.</li> <li>• The SENCo and other colleagues complete up-to-date training to ensure their effectiveness in offering advice and guidance to staff regarding the needs of pupils.</li> </ul>

<p><b>Sensory and/or physical</b>  <i>Some children require SEN provision because they have a disability which prevents or hinders them from making use of the educational facilities provided. Many children with Vision Impairment [VI], Hearing Impairment [HI] or a Multi-Sensory Impairment [MSI] will require specialist support and/or equipment to access their learning. Children with an MSI have a combination of vision and hearing difficulties. Many children require minor adaptations to the curriculum or the physical environment. Some children with a Physical Disability [PD] require additional on-going support and equipment to access all the opportunities available to their peers.
